# **NEW BUSINESS**

a) R-20-2 Resolution to Set 2020 Millage Rate to 1.755 Mills

<u>Rozier</u>: You have before you a recommended millage rate of 1.755 mills for the year 2020. The recommended rate is equal to the rollback rate. As an example, for a home with a fair market value of \$400,000 in 2019, the city property tax was \$302.24. For a home of the same value in 2020, the tax will be \$280.80, which represents a 7.09% reduction in taxes year to year. The citizen Finance Committee unanimously supports the recommended rate.

McDaniel made a motion to adopt R-20-2, a resolution to levy an ad valorem tax for the calendar year of 2020 at the rate of 1.755 mills on all property subject to taxation in the City of Berkeley Lake. Smith seconded the motion. All remaining council members were in favor and the motion passed.
