Can you stand any more great news?! After the FEMA news recently, I am writing this time to tell you some more. **Our city is now significantly larger than before.** The commercial area between the City of Berkeley Lake and Peachtree Industrial Boulevard has just been annexed into Berkeley Lake. That includes the area from Berkeley Commons north along PIB until it runs into our greenspace, including the banks, Peachtree Lakes Business Park, etc. We are indebted to our state representative Tom Rice and our state senator David Shafer who helped us to achieve this. It is much healthier for our city to have a broader and more balanced tax base that includes many types of properties rather than having such a preponderance of residential. And for most businesses we will actually be able to save them money relative to the possibility of their becoming part of Peachtree Corners or Duluth. That's because those both have stormwater utility fees and higher business license and occupational taxes. As you know, our city pays for stormwater needs out of our regular property taxes, and it costs businesses a small fraction for licenses and occupational taxes here of what they would pay elsewhere. So this is a win-win that will permanently change our city for the better. Woo Hoo!

Now we are working very hard on a **second wave of annexations on the other side of PIB.** As I write this, 17 businesses have already signed formal requests to be annexed into Berkeley Lake. Some time ago I sent a personal letter to each of about 70 businesses with a detailed comparison of each business's costs with us, with Peachtree Corners, and with Duluth. These letters were in most cases hand delivered to them by one of what I dubbed "our A-Team" - "A" for "annexation." The first of this group was **Rodney Hammond**, head of our Planning & Zoning Commission. It was largely Rodney's great vision that got us moving in this direction, because frankly, I was focused on the area on our side of Peachtree Industrial Boulevard and didn't dare to think as big as Rodney in the beginning. **Tom Rozier and Leigh Threadgill** came up with a truly amazing collection of facts and figures for each business. They researched, studied, computed, and presented an array of data and maps that would knock your socks off. Armed with all that, I joined Rodney in calling and visiting businesses, and recruited **Tom Kitchens and Dick Lackey** to the A-Team. All have worked tirelessly and given huge amounts of their time to this great challenge. **Anne Carpenter** has recently joined us as we push to get answers from the ones who have not yet decided before our deadline on October 6th. If you know a businessperson along Old Peachtree Road or between there and Peachtree Industrial Boulevard, please let us know. We are encountering some misinformation now in the area that you may be able to help clarify. **Marilyn Childress** has contacted several whom she knows on the city's behalf, and we appreciate her efforts. **Ultimately the more we broaden our tax base, the lower your own taxes as well as the taxes of the annexed businesses will be.** Commercial annexation was a goal suggested to us by the outside professional planner who helped us create our Comprehensive Plan a few years ago. The goal was confirmed by resolution of our P&Z Commission and City Council, and now it is becoming a reality. If you have any knowledge of or connection to any property over there, call Tom Rozier at City Hall and he can tell you the bottom line figures for each property.
